**Re: 2009 Crop hail, flood, or earthquake premium exclusion form**

In the past, every Texas licensed insurance company has been required to provide the Texas Windstorm Insurance Association with a copy of its annual year-end Texas State Financial page (Exhibit of premium and losses) by **March 1<sup>st</sup>** of each year. The information from the Texas State page was used in the calculation of the percentage of participation in the TWIA for each member company. TWIA is no longer requiring this page and will rely on information provided to us by the Texas Department of Insurance.

TWIA will still need to collect the supplemental exclusion form that indicates if your company has any premium for **crop hail, flood, or earthquake** included in lines 2.1, 3, 4, and 5.1 on the 2009 Texas State Financial page.

Attached, please find the form to identify crop hail, flood, or earthquake premiums where they are included on lines 2.1, 3, 4, or 5.1 of your 2009 annual statement. **Please return the supplemental exclusion form by March 1, 2010 to:**
